Additional time and materials may be charged under the following example scenarios:

CHN	Low concentration samples; salts; liquid samples
TOC	Any sample matrix other than water
ALPKEM	Any sample matrix other than 2M KCl or water; any sample not near neutral pH; colored samples; dirty samples
COSTECH	Salts; glass or quartz filters; highly enriched samples (> 2 atom%)

<sup>3</sup> Solid samples should be sent to EcoCore weighed and encapsulated. We occasionally weigh and encapsulate samples for outside clients for an additional charge.

<sup>4</sup> Training and consulting fees are charged by the hour (@ \$88.40/h) for instrument, method, and lab use training sessions.

Training on instruments needs to be re-taken if operator has not run the instrument for over 6 months.

Other notes:

**Client vs. EcoCore operator:** for most automated analyses, a sample surcharge is included when samples are sent to and analyzed by EcoCore, to cover for time investment by laboratory technicians.

If instruments are run by the client, training is required, which will be charged by the hour (@ \$88.40/h) for instrument, method, and lab use training sessions.
